SCHOOL FEE POLICY

To facilitate enrollment of children from the same family at Al-Noor Academy and the Islamic Academy of New England (IANE); the school board has adopted the following tuition policy.

Tuition Fees

PreSchool (3yr & 4yr old by October 31st)	\$8,250.00
Kindergarten (5yr old by October 31st) – 8 th grade	\$7,550.00
9 th – 12 th grade	\$8,750.00
PreSchool - 3 days/week	\$5,290.00
PreSchool - 4 days/week	\$6,760.00

Tuition Discounts:

- Siblings' discount: families with multiple children enrolled will receive a discount of \$450 for each child including the first child.
- Dual enrollment discount: students in the dual enrollment program receive a discount of \$2,000.

Other Fees

1. Deposit for new student (deposit will be applied towards last payment) ----- \$450
Deposits must be submitted with applications by April 30. **The deposit is refundable only if admission is denied.**
2. School Uniforms are purchased directly from supplier(s) Note:
Returning students must register by April 30th deadline.
A late application from a returning student will be treated as new based on availability of space i.e. admission will not be guaranteed.

Payment Plans (ask the registrar about available payment plans)

Payments are made directly online with Smart Tuition w.e.f. June 2016

- Plan I - One payment - Payment of entire fees by June 1.
Plan II - Two payments - Due by June 1 and November 1.
Plan III - Four payments - Due by June 1, September 1, November 1 and February 1.
Plan IV - The school may have a 3rd party payment plan with multiple options; please consult the Registrar.

Delinquent Accounts Policy

The account is considered delinquent if a payment is late for more than 30 days. Students with delinquent accounts may not be allowed to attend classes. Student report cards and academic records will not be released until payment is made in full. Students with delinquent accounts will not be eligible for readmission for the next academic year.

Withdrawal Policy

1. Parents are liable for 25% of annual tuition fees, if student(s) withdraw during September.
2. Parents are liable for 50% of annual tuition fees, if student(s) withdraw during October-November.
3. Parents are liable for 100% of annual tuition fees, if student(s) withdraw after November 31.
4. Deposit of \$450.00 is nonrefundable in any of the above cases.

Part-Time Pre-School Policy

1. Attendance is strictly based on normal school days as published on the school calendar.
2. Any absence on scheduled days of attendance cannot be "made-up", without exception.
3. Please **initial** next to the selected days: Monday Tuesday Wednesday Thursday Friday
